Our menu is short and straight to the point. Designed by the well-known chef Tomislav Martinovic (from Heston Blumenthal's The Fat Duck), Five Points Burgers is the total New York experience with a wholesome Aussie flavour.

From our interior fit out with decorative scaffolding, raw concrete walls and industrial chic pendant

lighting, the key menu items are all named after the New York boroughs:

- > The Bronx
- > Queens
- > Manhattan
- > Brooklyn
- > Staten Island.

Like New York City, Five Points Burgers buzzes with customers who are happily enjoying grain fed Australian beef, free range chickens and fresh veg. On most days the queues are out the door and it takes a good 20 minutes to make it to the counter to place an order. But it's always worth the wait.

### Franchise Journey

Making the choice to operate your own business is a big but exciting step, which is why we're committed to making the process as open and informative as possible. It's an important decision for both of us, so we'll provide all the support and information you need to help you make the right choice for you and your family.

<b>STEP 1</b>	Send us an enquiry		
<b>STEP 2</b>	Five Points Burgers gets in touch and sends you a Franchise Brochure, Franchise Application Form, Confidentiality Agreement and Franchise Information Statement.		
<b>STEP 3</b>	You read through the brochure and fill in the Franchise Application Form and sign the Confidentiality Agreement and then send it back to Five Points Burgers .		
<b>STEP 4</b>	We meet to get to know each other better and answer any questions you might have.		
<b>STEP 5</b>	You conduct your due diligence and pay a refundable document fee of \$3,000.

<b>STEP 7</b>	The \$3,000 document fee is now allocated to finalising and customising the Franchise Agreement (see the Franchise Agreement for more details).		
<b>STEP 8</b>	After 14 days from receiving the final franchise documents, The Franchise Agreement is signed, and the balance of fees are paid.		
<b>STEP 9</b>	A site is located and fit out commences. Training is organised ready for you to commence trading.		
<b>Step 10</b>	When all is done, we will have an opening launch to celebrate.		

## Frequently Asked Questions

### What qualifications do I need to be a Five Points Burgers Franchisee?

No particular qualifications are required to operate a Five Points Burgers franchise. What you will need however is a willingness to work hard, to learn from others, and to stay open to new ideas and opportunities. You must have a strong work ethic and be willing to follow our tried and tested business systems.

### What do I get for my franchise fee?

- ✓ You get the right to operate as a Five Points Burgers franchisee in your exclusive territory for a period of 5 years with another 5-year option to renew.
- ✓ You receive a fully fitted out shop ready to trade including equipment, stock, business software and more.
- ✓ You receive comprehensive training, marketing material, uniforms etc.
- ✓ You receive a support from our well-trained staff to help you start your journey

### What does it cost to buy a Five Points Burgers Franchise?

Five Points Burgers franchises are very well priced. The costs are as follows:

Franchise Fee \$34,900 + GST  
Shop Fit Out (ranges \$117,000 - \$150,000 depending on size and location)

Working Capital \$20,000 - \$30,000  
So, all up you'll need is around \$170,000 to \$215,000.

### Do I get an exclusive territory?

How will I know other franchises won't flood the area? Yes. When you sign your franchise agreement you will be provided a designated exclusive territory defined by a map so no other Franchise will be able to advertise their business in your territory.

Franchise growth will be strictly controlled and monitored to ensure the market does not become saturated.

### Why do I need to pay a document deposit fee to examine the business fully?

Providing all the information you need to evaluate the opportunity and making the right decision for you requires a lot of time from a lot of people. So, we need to know that you are genuinely serious about the opportunity. Rest assured however, that your document deposit is refundable should you decide not to proceed.
